Request under the *Freedom Of Information Act 1982* for access to documents

I refer to your request under the *Freedom of Information Act 1982* (FOI Act) received by this office on 5 June 2014 in the following terms:

Three substantial redemptions (about \$500,000.00, \$1m and \$800,000.00) carried out between May 22nd 2008 and June 18th 2008. The money was transferred from ASF and ended up with the ARP Growth Fund.

Documentation of the destination of these amounts. We do not seek personal names or details..

I am the authorised decision-maker for the purposes of section 23 of the FOI Act.

I have identified a document which comes within the terms of your request. This document is described in the Schedule to this letter.

Relevant legislation

Section 47F of the FOI Act relevantly provides

General rule

- (1) *A document is conditionally exempt if its disclosure under this Act would involve the unreasonable disclosure of personal information about any person (including a deceased person).*

- (2) *In determining whether the disclosure of the document would involve the unreasonable disclosure of personal information, an agency or Minister must have regard to the following matters:*
- (a) *the extent to which the information is well known;*
 - (b) *whether the person to whom the information relates is known to be (or to have been) associated with the matters dealt with in the document;*
 - (c) *the availability of the information from publicly accessible sources;*
 - (d) *any other matters that the agency or Minister considers relevant.*

Section 22 of the FOI Act provides that if an agency or minister decides to refuse access to a document on the ground that it is exempt, the agency or minister must consider whether it would be reasonably practicable to prepare an edited copy of the document, which has been modified by relevant deletions, for release to the applicant. If the agency or minister decides that giving access to a document would disclose information that would reasonably be regarded as irrelevant to the request, consideration should be given to preparing an edited copy for release to the applicant. The decision maker should consider the nature and extent of the modifications required, the resources available to modify the document and whether the applicant would accept an edited copy.

Decision

I have decided to release the document in the attached Schedule which has been modified to delete irrelevant material and exempt material as discussed below.

Section 47F provides that a document is conditionally exempt if its disclosure under FOI would involve the unreasonable disclosure of personal information of any person. The test of unreasonableness implies a need to balance the public interest in disclosure of information and the private interest in the privacy of individuals.

In relation to document in the schedule, I consider that release of this document in its entirety would unreasonably affect a person's privacy, and would be contrary to the public interest in that it would compromise ASIC's work. I find that information regarding the identity of the recipients of funds is exempt from release under s47F of the FOI Act.

Pursuant to s22 of the FOI Act, I have prepared an edited copy of the document, which has been modified to delete information which is exempt under s47F of the FOI Act.

Review Rights

I provide you with the following information as required by section 26 of the FOI Act.

In the event that you are dissatisfied with the decision:

1. You may, within 30 days after the day on which you have been notified of this decision, apply in writing to ASIC for a review of my decision by another ASIC

officer under section 54B of the FOI Act. This request should be addressed to me or to the Senior Manager, Administrative Law GPO Box 9827 SYDNEY or by email to foirequest@asic.gov.au

3. You may lodge a complaint to the Australian Information Commissioner in respect to the conduct of ASIC in the handling of this request.
